### Subject: Official Request to Inspect Association Records Pursuant to Florida Law

Dear Members of the Recreation Association Board,

I am a homeowner and member of Delray Villas Plat 1 and, accordingly, a member of the Delray Villas Recreation Association ("the Association").

This letter constitutes a **formal request for access to and copies of Association official records** pursuant to **Florida Statute §720.303(4)** and in accordance with the Association's adoption and use of electronic voting under **Florida Statute §720.317**.

Specifically, I am requesting the following records related to the authorization, implementation, and administration of electronic voting:

# **Requested Documents**

# 1. Electronic Voting Resolution

 A complete copy of the board-adopted resolution and meeting minutes authorizing electronic voting, including the date of adoption and all amendments.

# 2. Electronic Voting Policies and Procedures

 All written rules, procedures, and administrative guidelines governing the use of electronic voting, including timelines, submission process, vote counting, and certification procedures.

#### 3. Member Opt-In / Opt-Out Process

 All forms, notices, and procedures used to obtain member consent to vote electronically, including any process for members to revoke consent or revert to paper/in-person voting.

#### 4. Voting Window & Deadlines

 Documentation specifying when electronic voting opens and closes for all elections or membership votes, and whether voting remains open during meetings.

#### 5. Vote Revocation or Change Procedures

• All procedures that define how and when a member may revoke an electronic vote and submit a new vote in person or electronically.

#### 6. Quorum and Vote Tabulation Procedures

 Policies confirming whether electronic votes count toward quorum, and procedures for tabulating, validating, recounting, and certifying electronic votes.

### 7. Security, Authentication, and Record Retention

- Documentation identifying the electronic voting platform being used, including:
  - Identity authentication methods
  - Vote secrecy and receipt confirmation
  - Record retention policies and availability of audit logs or independent voting records

# 8. Member Authorizations for Electronic Voting

 Copies of any and all member authorizations, consent forms, electronic acknowledgments, or records of member approval permitting the use of electronic voting, including both individual optins and any general membership approvals or resolutions authorizing such use.

These materials are classified as <u>official records of the association</u> under Florida **Statute §720.303(4)** and must be made available for inspection or delivered to me within **10 business days** of receipt of this request. Failure to provide the requested records within the statutory timeframe creates a rebuttable presumption of a willful violation under §720.303(5), subject to penalties and member remedies.

Please provide these documents in **electronic format (PDF or similar)** if available. If any of the requested documents do not exist, please provide written confirmation of nonexistence.

Failure to provide access to these records will result in the filing of a complaint with the Florida Department of Business and Professional Regulation or other appropriate legal action. I trust that such steps will not be necessary and that the Association will comply fully and timely with this lawful request.

Please confirm receipt of this letter and provide a proposed date and time for inspection or delivery of the requested records. Thank you for your prompt attention. I look forward to your compliance as required by law.
